# Deliveroo Pedestrian TV Free Delivery Competition Terms and Conditions

# Background

- 3. The promotion period is on and from 6.00am AEST Monday, 5th of August 2019 to 5.00pm AEST Thursday, 31st of October 2019 (**Promotion Period**), entries must be received before the end of the Promotion Period in order to be valid.
- 4. By entering this promotion, you acknowledge that you have read these terms and conditions and that you agree to be bound by them. Information on how to enter form part of these terms and conditions.
- 5. The daily prize is free delivery with Deliveroo for a year in the form of a credit up to the value of \$322.20 to be applied to the winners Deliveroo account.
